



Puppy Sales Contract And Agreement

This **Sales Contract and Agreement** (“Agreement”) is made by and between Pamela Lovett, LLC, dba Pamela Lovett Cavaliers (“Seller”), located at 3610 Columbine Circle, Charlotte, NC 28211 and _____ (“Buyer”) located at _____.

Seller agrees to sell Buyer a puppy/dog (“dog”) born on _____. Litter # _____
Sire: _____ Dam: _____

For the Sum of _____, plus 7.25% sales tax, if applicable.

- 1) Buyer agrees to provide a comfortable environment, prompt medical attention, proper grooming and responsible care to its dog. This includes keeping dog parasite free and providing it with current inoculations, proper nutrition, fresh water and a safe environment at all times. Seller strongly recommends that dog be microchipped or tattooed in order to facilitate its return if lost or stolen.
- 2) Seller guarantees dog to be of sound health and temperament at the time of sale and shall provide Buyer a record of shots and wormings. Buyer agrees to take dog to a licensed veterinarian within 72 hours of purchase for a physical examination. Should dog be determined to be in ill health, Buyer may, upon signed written diagnosis from said veterinarian, return dog for refund of purchase price paid. Buyer expressly agrees that Seller’s total liability shall in no event exceed the purchase price paid by Buyer.
- 3) Buyer agrees not to use this animal for breeding and to have it spayed/neutered at the age recommended by their veterinarian (usually 6 months to 1 year of age). Dog will be on limited AKC registration.
- 4) If, at any time, Buyer can no longer retain possession of dog, Seller is to be notified and given first option of resuming full ownership of dog in order for Seller to locate dog a new home. In this event, refunds, if any, shall be at the discretion of Seller. Dog will be returned with all AKC papers and medical records. Should any circumstances arise that affect the quality of life of dog, Seller is to be informed in order to participate in determining the future of dog, if Seller so chooses. Under no circumstances will dog be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility.
- 5) Buyer agrees to contact Seller immediately if any questions or concerns arise regarding dog, such as housing, diet, health or training. Buyer agrees to keep Seller informed of any treatment as it occurs. Such communications provide Seller with important feedback and information regarding the health of its dogs for future generations.
- 6) Registration papers will either be given with dog or transferred to Buyer immediately upon receipt from AKC if they are still being processed. It is understood at the time of sale that this is a pet quality dog and is representative of its breed. It is structurally and temperamentally suited as a loving, playful companion dog. Training classes are recommended for a happy relationship between dog and family.

The preceding paragraphs contain conditions established to ensure the well-being of dog, but also to uphold and maintain the reputation of quality that Pamela Lovett Cavaliers has established over more than a decade. This Agreement shall continue for the duration of dog’s life.
